

## RULE SHEET:

### 1. you want to become a NADEUM member.

You can opt for the following types.

#### **Active member:**

You actively participate in NADEUM's own projects with your knowledge and actions. It is your decision how you want to contribute.

#### **Passive member:**

You support the activities of NADEUM through financial contributions.

**Honorary member, lighthouse, ambassador:** Through your voluntary work, you convey a project of your choice to future interested parties: 1. inside what vision has been defined as the goal and how it will contribute to solving many problems.

### 2. you want to become a part of this network:

Your goal is to remain independent. But you want to be a part of this movement. Then you can become a NADEUM partner. (No say within NADEUM)

### 3. DSGVO 2018 / DSGVO 2000 / is now called Data Protection Act (DSG) [Data Protection Authority].

**NADEUM has not**, to date, stored, processed, used, or disclosed to any outsider any personal data in relation to personal DATA, third parties.

Without the consent of the respective persons and their agreement to their data for a respective project, no personal DATA will be passed on externally by NADEUM.

2]

**NADEUM, the association**, deletes all personal data of third parties upon termination of active projects.

However, we are obliged to keep all financial data for 7 years in order to be able to give correct information to the tax authorities at any time.

**NADEUM, members** belonging to the association and their personal data, whether active or passive, are stored as long as they are part of the association NADEUM.

3a]

**If a NADEUM member leaves** the association due to his or her wish or in case of gross negligence, his or her personal data will be deleted insofar as all debts have been repaid and material assets belonging to the association have been returned.

3b]

**However, if the NADEUM member still** has external payment obligations to the association when he/she leaves, his/her personal data will be kept as long as the debt has not been repaid.

NADEUM, the association,

provides a DSGVO - Data Consent Form [DZB] = Member Registration Form for download. All persons wishing to work with NADEUM should complete the DSGVO - DZB and email it to us as a PDF FILE attachment [verein@nadeum.eu].

4a]

By signing the internal data processing, you consent to the storage, processing and use of your personal data within NADEUM. The data will be deleted after 5 years, at the latest when the respective NADEUM board is newly elected.

4b]

All internal and external persons who continue to work with NADEUM must then agree to new data processing by signing a new member data consent form [MDZB].

5]

Persons who send business cards to the Board of Directors, the President or the Press Officer in the course of events will only be informed about the respective subject matter. This personal data is only relevant internally.

If, in the course of this, cooperation in existing projects should also become publicly active, these persons would also have to fill in a DZB. Without this written consent, no data of any kind about the person and the active cooperation in the respective project will be put online.

5. **to all African interested parties:** We at NADEUM know that you receive a much lower budget / remuneration for your services in comparison to Europe. Nevertheless, we ask you to make a membership contribution that is affordable for you.
6. **Why is this so important** to the NADEUM Board? Without a value, the cooperation with the association "NADEUM" is not appreciated enough. We are a small Austrian association. Nevertheless, our goals are challenging. If you are a full member of our association, you will have access to an international network. And you become part of this network. You can trust that as long as you are loyal to the association, we will support you with our knowledge.
7. **If you respect NADEUM's** own statutes, you will realise that you will gain in knowledge and added value. Also, please know that we at NADEUM value your input very much. We, as a worldwide team, do our work free of charge. All services provided within the NADEUM association are, up to a certain point, free of charge.
