And on Saturday, 6pm (6p.m. CET) the video conference will start, we will do it again via the platform we already use. Everyone will receive the links in good time.

We would like to point out that the following information and future paragraphs dealing with voting rights concern the legal situation in Europe.

The respective Presidia of the local NADEUM branches are responsible for answering questions about the handling in other EU or national territories.

1) If it says, 'Member of the NADEUM Presidium of Vienna' abbreviated to '**MNP-Vienna**' then the member in question is a 'CEO' or a 'President of a Branch' or 'Ambassador of NADEUM'. All these persons, including the NADEUM Presidium in Vienna, then have a voting right in the Presidium of the NADEUM Headquarters

1a) All NADEUM members who are listed as members at the head office have the right to vote at the annual General Assembly.

2) From 2024, the upcoming General Assemblies will take place in January of the following year.

The reason for this is that we have massive clashes of dates in Austria in December. Advent, Christmas, New Year and, above all, shopping activities. Everyone wants to celebrate with their families. They are extremely stressed.

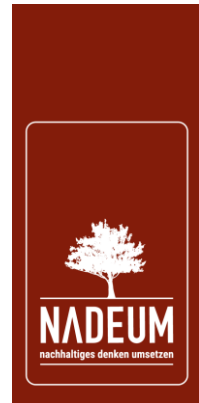
3) Members who are only members of a 'NADEUM branch':

These can only bring their voice to the head office in Vienna (Austria) through their respective chairman/president.

3a) If the **members of the NA DEUM** branch require support from the head office, this must be agreed at a board meeting in their national branch. This means that the locally elected executive committee must convene a general meeting. At this meeting, the desired topic is submitted, put up for discussion and voted on. [the majority decides / 51%, the higher the better]

[ATTENTION: There is no financial support from the head office. However, we endeavour to make this possible by providing paid work assignments]

3b) **This gives the President of the national branch the right to vote and the duty to** put this topic on the agenda of a General Assembly in the Presidium in Vienna on behalf

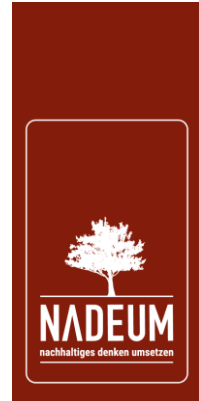

of the national branch members. (There, too, the majority decides whether this topic is dealt with and put up for discussion).

3c) It **is advisable** to inform the Presidium of the wishes at least 3 months before the General Assembly to be held in January. This must always be done in writing.

3c1) **Verbal requests or commitments are only possible** if there is a written confirmation from the head office. Every request must be confirmed in writing by the Vienna Presidium. If this is not done, the branch office has the right to demand this.



4) **The NADEUM head office has no voting rights in the respective branches.**

6) However, each branch and its Presidium may invite Presidium members from Vienna as guests (whether digital or analogue).

5) **The Presidiums and the 'NADEUM branches' are independent legal entities.**

5a) Therefore, the Branch Presidium is also personally liable for itself. The branch presidium is responsible to the NADEUM branch members. (liable)

5b) In the event of loss of the cash box or improper administration, each member of the Executive Committee is liable both individually and collectively for financial and material damage. (Here the association law of the respective state comes into effect).

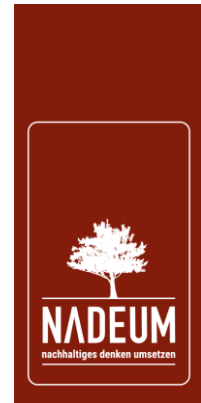

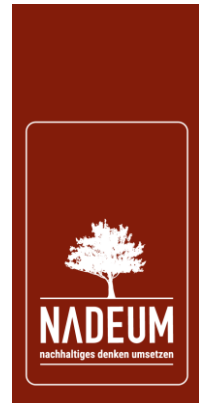

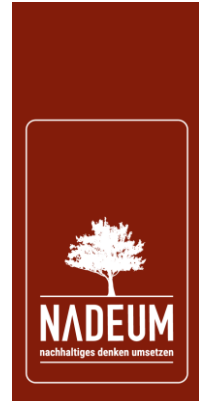

Now to the points of the day:

1) An invitation to 'Africa 1' (<https://meet.nerd.re/afrika-1>) will be sent to all participants half an hour before 6 pm CET. This will be sent to the WhatsApp phone numbers they have given us.

2) At 6 p.m. (6 p.m. CET) the meeting will be opened / we will wait a maximum of 15 minutes if there are still some missing.

3) To all attendees:

When it is your turn, please introduce yourselves briefly:

3a) We hope that you have read through the protocols. And thus, confirm that everything is in order. Or you may want to add something.

4) Since everyone will be present, it depends on who has a working internet connection. If it is the women from Kenya, Botswana or South Korea, they will be the first to introduce themselves and comment on ACAPMUSSC-MYC.

They will be followed by the two IT experts from Sierra Leone. They were invited at short notice. They will be asked to briefly introduce themselves and then give their opinions.

If the ideas of the newcomers lead to serious findings, there may be a fourth video conference in August.

4) All members will now be able to contribute. We think that everyone should have 3 to 5 minutes to speak.

After that:

5) Andreas our General Secretary will briefly explain the mental 'Social Competence Training'. Then everyone can announce whether they would like to take part in this free NADEUM training. First of all, those who learn more than just for themselves can also be trained as trainers. This would give everyone the opportunity to earn extra money

6) Let's see how much time has passed. If there is still some time left, GAFÉIAS and its Austrian partners will also present the IT project. All those who have IT knowledge and are interested in this earning opportunity can ask Andreas about the exact requirements needed here,

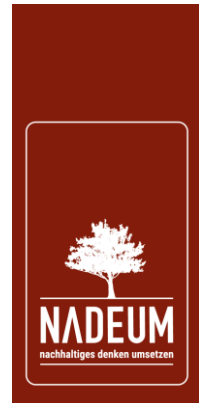
7) Adoption. Announcement of the new date. Depending on the data input, a fourth date in August or September will be necessary.

**‘African Community Action Programme for the Mobility of University
Students and Skilled Craftspeople-as-well-as-Migration, Youth-and-Children’**



Why has it now been taken to this expanded level?

The first question was: ‘What happens to the many young mothers whose husbands or fathers do not face up to their own role as fathers?’ CHILDREN (natives and migrants)

ALSO, we need kindergartens from birth to the age of four. Where young mothers learn like their children.

Kindergarten: from the age of 1 to the age of 4"

The second question was: ‘What happens to the many children whose parents are not able to help them at school? ’YOUTH (natives and migrants)

ALSO, there is a need for primary schools - primary schools where children acquire their basic knowledge in 3 stages.

Preschool: 5th year of life to 7th year of life

Primary school 1: age 8 to age 12

Primary school 2: age 13 to age 15

The third question was: ‘How can Africa be built up or renewed if children, adolescents and young adults see no perspective in their lives? If they are not taught what is important and right in nature.'"

ALSO, there is a need for vocational and nature schools or grammar schools. These schools are the basis for later study, if desired. Intermediate level - Secondary schools where children and young people can find out which subjects they want to study

Intermediate school 1: 16 to 18 years of age (*) > Universities

Secondary school 2: 16 to 20 years of age (vocational school 1)

Secondary school 3: 16 to 22 years of age (vocational school 2)

The fourth question was: How can recycling be promoted? How can we teach how everything is connected. (natives and migrants)

ALSO, we need specialised technical colleges. These also offer the internationally recognised bachelor's degree (*)

Technical college 1: 18 years of age to 21 years of age
University of Applied Sciences 2: 18 to 23 years of age
University of Applied Sciences 3: 18 to 27 years of age

The fifth question was: Who can afford to study at a higher level? (natives and migrants)

To be honest, the state should be able to afford it.

ALSO: And the state is obliged to offer prospects. In Africa, the first two years of working life could or should be accompanied by support measures. Afrika could take an example from Austria here.

There is the 'AMS' = labour market service. Anyone who gets stranded receives active support from here. Be it through retraining. Be it to become self-employed. Be it to accompany someone psychologically.

Support measures: from the age of 16 until ? as long as the person needs help to help themselves. His institution is obliged to offer courses of all kinds and to make them possible. In other countries need workers because they don't have skilled tradespeople or IT specialists, temporary employment agencies could open up new prospects for both sides. On the one hand, the state would benefit by hiring out trained specialists and, on the other hand, unemployed people would get temporary jobs abroad.

The sixth question was: If I am given the opportunity to study.

If I get the opportunity to study, the learner will have to attend a university of applied sciences, vocational schools and grammar schools. These are basic prerequisites for later studies.

NADEUM has realised that many Africans have an excellent education. However, there are too few jobs.

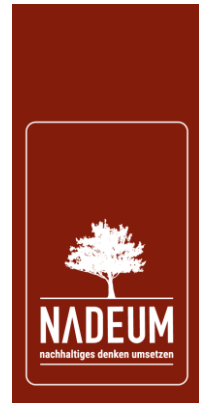
The young people are simply left in the lurch. He is desperate. In their own interest, the state has to act in its own interest so that there is a regular working life. Not everyone has to get rich. But people need prospects.

Studying at a university is possible from the age of 18.

All specialisations are possible. All specialisations are possible. If a person can afford it, they can study their whole life.

The state should draw a line at the age at which studying becomes subject to a fee. We suggest the Age of 30.

NADEUM suggests the age of 28 as the maximum first stage. This means that if you start studying at the age of 18, you should finish after a maximum of 20 semesters. This is the time that a state that wants to be among the best in the future should make possible for its population. A degree programme should be completed as quickly and as well as possible. Every degree programme has different training periods, which should be determined by the state in an expert task force.



Here is an example of how it is handled in German-speaking countries. There are several degrees. Every degree requires that there is already a previous degree: see <[Wikipedia.at](https://www.wikipedia.at)>

Bachelor: from 4 semesters up to 9 maxima

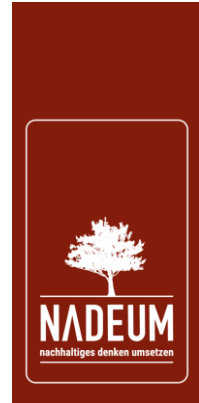
Master: from 4 semesters up to 10

Magister and Diploma: at least 6 semesters, sometimes 8 and sometimes 15

Doctorate: up to 8 semesters

For doctoral theses, which actually only exist in Europe, a separate thesis is required for each degree. This means you have to find a topic of your choice and carry out research. It must be completely new. Writing from other people or quoting quotations that are not your own or whose source is not disclosed can result in the degree being revoked. Universities that do not adhere to these regulations will be officially branded. **(Plagiarism is severely penalised, up to and including the revocation of the title).** All degree programmes have one thing in common: they can last from the 4th semester to the 15th semester

There will be a more detailed financial plan. This will require you or us to research the official financial data of the countries within the AU. AU = African Union) 55 States are recognised within the AU.
